### **2024 ELECTIONS:** Global Impact and Indo-German Collaboration

#### Dear Members and Friends of IGCC,

We are already two months into 2024. This year will be a year of elections. The largest election will be held in India. Maybe the most important one for the coming years will be the Presidential elections in early November in the USA. Sometime in between, early June, the member states of the European Union will elect a new parliament and a new EU Commission.

In India, almost all experts expect continuity. Based on the enormous popularity of the Prime Minister and strong economic performance, it is broadly expected that PM Narendra Modi will be elected for a third term. This will also mean political continuity, which was already visible when the Finance Minister presented the preliminary budget for the coming fiscal year. No significant new policies have been announced, and the focus on public infrastructure investments will remain. Economic growth is forecasted to remain at a similar level. This will also mean that the role of India in the global economy and geopolitics will continue growing for years to come.

The outcome of the elections in the EU is much more difficult to predict. There is a significant concern that in several EU member states, including and most importantly Germany, right-wing populists may be the winners of the elections. Most of them are EU-critical, and some are even explicitly anti-EU. Political leaders in Europe see a rapidly increasing necessity, even urgency, to strengthen the European Voice and especially the EU's military capabilities. An outcome, which weakens EU institutions would most likely undermine those efforts and further harm the EU's geopolitical standing. The further implementation of farthe EU Green Deal could be impacted as well.



These changes require staying up-to-date and keeping up with unpredictable advancements in technology. This technology optimizes and processes information at a quicker pace and more efficiently than regular computers. As a result,

quantum computers facilitate faster decision-making. It is worth noting that India has also been gaining momentum in exploring quantum technology. In 2020 the Indian government launched the National Mission on Quantum Technologies and Applications (NMQTA) with a budget of 1.2 billion USD for five years. In Hamburg, the development of quantum technology has made significant Office for Information Security recommending post-quantum

cryptography. An estimation of a global market volume of USD 280 million by 2024, has accelerated the city-state's efforts in this regard.

Quantum computers hold huge potential for the aviation, shipping, manufacturing, and logistics sectors, by simplifying complex industrial processes in manufacturing and machinery. Especially in the supply chain sector, where quantum computers can be of enormous help by adapting to changing conditions and adjusting the results swiftly in maintenance, flight routes planning, gate assignment, and air cargo distribution. In the shipping sector, these applications can also be transferred to shipping e.g., route planning, ship loading

at the forefront of quantum technology development, aims to utilize its potential for industrial progress and environmental

technology companies to create a quantum computer specializing in optimization problems by 2026. The project is being funded by the German Ministry for Education and Research as a part of the Quantum Computer Demonstration Setups scheme. Further, the City of Hamburg has earmarked EUR 10 million for quantum computing projects. IFB Hamburg is backing R&D companies and start-ups that are striving to come up with innovative products, procedures, or services in quantum computing. Quantum computing thus has also proved to be a hopeful field of business with a possible receipt and investment of upto EUR 1.5 million.

Additionally, in November 2023, the City of Hamburg organised the conference "Quantum Readiness: Funding and Application Opportunities in the Hamburg Metropolitan Region", in collaboration with Hamburgische Investitions- und Förderbank (IFB) and Hamburg Quantum Innovation Capital (HQIC). The conference highlighted Hamburg's quantum computing ecosystem and has warranted further exploration of Quantum Technology in the future by Hamburg.

Quantum technology now stares at a promising future of increased production, capacity building, investments and an area of fruitful collaboration between India and Hamburg.

he Spielwarenmesse has succeeded in asserting its unique leading role in the global market. Between 30 January and 3 February, the entire industry came together at the Nuremberg Exhibition Centre for its sole global event of the year. 2,354 exhibitors from 68 countries - an increase of 10% over the previous year - took the opportunity to publicise their trends and new ideas. Alongside the product innovations, a multitude of different networking opportunities and stimulating ideas on the lead theme of Kidults awaited the 57,000 visitors from 125 nations who gathered there.

of US company Wyncor. As a consequence, the importance of the trade event continues to rise. 97% of the exhibitors (2023: 95%) considered participation in Nuremberg to be important or very important. "As the leading trade fair, the Spielwarenmesse is the place where everyone from all over the world meets. You won't find

these opportunities anywhere else," declares Ram Ronen of PMI Trading & Enterprise. For the Vice President, the fair is the ideal opportunity to meet up with existing customers and to generate new contacts. 

### The German Machine Tools and Machinery Industry

ne German machine tool industry, renowned for its precision engineering and innovative spirit, navigated a complex landscape in 2023. While the year opened with promises of growth, the latter half witnessed a decline in orders and a cautious outlook for 2024.

#### **STARTING STRONG, FINISHING UNCERTAIN**

2023 started with a bang for the industry, boasting a 9% production growth to reach EUR 15.2 billion. This success was fuelled by a backlog of orders built up during the pandemic. However, the celebratory mood didn't last. New orders painted a contrasting picture, revealing an initial 11% decline compared to the previous year. While a slight recovery followed, a sharp 9% drop in Q3 orders ultimately led to a 7% decrease for the year.

This divergence highlights the industry's reliance on external factors. Despite impressive internal production, new orders, the lifeblood of future growth, faltered.

This vulnerability stems from the sector's dependence on exports, with a staggering 70% of production leaving home shores.

Yet, a glimmer of hope shines through. The US market, driven by investments in climate and renewable energy, experienced double-digit growth, offering a potential engine for future expansion. However, navigating the uncertainties of global economic headwinds and shifting order patterns remains the key challenge. Can the industry capitalize on external opportunities while diversifying its customer base and mitigating export dependence? Only time will tell the ending of this production story, currently suspended between a strong start and an uncertain finish.

### **CHALLENGES AND OPPORTUNITIES**

While the production story presented complexities, the road ahead isn't without its challenges and opportunities. The industry faces headwinds from global forces like the Ukraine war, surging energy








### India projected to become the 3<sup>rd</sup> largest economy by 2027

corpus of INR 1 lakh Crore (i.e. INR 1 Trillion) set aside to promote private investment in sunrise technologies. A new scheme will also be announced for strengthening deep-tech technologies for defence purposes, which has seen a 4.5% increase in allocation from last year. Numerous green initiatives were announced to fulfill the government's 'net-zero by 2070' commitment. These include viability gap funding for wind energy, mandatory blending of biogas and natural gas for transport and domestic use. Proposals also include setting the capacity for coal gasification and liquefaction by 2030 to reduce imports of critical items like methanol and ammonia. The government is dedicated to expanding the e-vehicle ecosystem by supporting manufacturing, charging infrastructure, and promoting

Facilitating Growth ndia's Finance Minister Nirmala Sitharaman had clarified that the Interim Budget 2024 was going to be a 'vote on account' with no big-ticket announcements, owing to the election year. The focus remained on continued growth amid global geopolitical uncertainties and working towards enhancing the GDP powered by Governance, Development and

#### **PROGRESS OVER THE PAST** DECADE

Performance.

In keeping with tradition, the interim budget was preceded by a report titled "Indian Economy – A Review,"<sup>1</sup> summarizing the highlights of the Indian economy in the past decade. The report emphasized transformative changes made for ease of doing

business, including the introduction of GST, simplified tax regimes, expedited processing of income tax returns, revamped reporting under corporate law, enactment of the Insolvency and Bankruptcy Code, 2016, and increased transparency in the banking system. These changes, along with others, have boosted confidence, widened the tax base, and led to record tax collections for the government.

It was further highlighted that the last decade has been very progressive for the country, with FDI inflows doubling to USD 596 Billion during 2014-23 from the previous decade

and the average real income of the people also increasing by 50%. It was also announced that the government will release a white paper detailing the progress of the economy since 2014-indicating the confidence of the current government in having delivered on their initial promises and boosting transparency.

#### **ECONOMIC PERFORMANCE<sup>2</sup>**

India's real GDP is expected to grow at 7.3% this year, in line with upward revisions from RBI in recent months, prompted by a strong Q2 of FY 2023-24. The fiscal deficit for FY 2023-24 was revised to 5.8% as

against the estimated 5.9%. The budget estimates for FY 2024-25 have pegged the fiscal deficit at 5.1%, keeping with the target of 4.5% set for FY 2025-26.

#### **KEY ANNOUNCEMENTS:** MAINTAINING COURSE AND **FACILITATING GROWTH**

This budget was not completely devoid of any policy announcements, with the objective remaining to build on the strong foundation from past years. The FM announced an increase of over 11% in capital expenditure outlay on infrastructure, being 3.4% of the GDP. Key economic railway corridors were also announced to further expand the reach of railways and their benefit to industry and the common public.

There is also a strong thrust given to R&D and innovation, with a

greater adoption of e-buses for public transport. Additionally, a new scheme for bio-manufacturing and bio-foundry will provide eco-friendly alternatives for materials with a wide range of industrial applications, aiming to widen access and further boost acceptance among the general public.

Regarding taxes, the proposals involve withdrawing specific petty direct tax demands for identified periods to ease tracking and litigation efforts, benefiting over 10 million taxpayers. On the GST front, there is a proposal to mandate the distribution of GST credit for common input services. Additionally, a penalty is suggested for manufacturers of goods like Tobacco and Pan masala in case of non-compliance with specified procedures in GST.

The budget announcements left Indian taxpayers wanting more, anticipating relief on the personal tax front, including enhanced deduction limits and rationalized income slabs. India Inc. hoped for an extension of the concessional tax rate for newly established manufacturing operations (under section 115BAB) and clarifications to address litigation risks post-recent landmark judgments. Corporates were optimistic about GST rate rationalization for EV-related components and customs duty adjustments on the indirect tax front. Despite this, there is still hope for relief in the final budget postelections.

#### **IMEEC: REVOLUTIONIZING GLOBAL TRADE**

The India-Middle East-Europe Economic Corridor (IMEEC) was also referenced by the FM and touted as a game changer for bolstering world trade. Tabled during India's presidency of G20 with an MoU for development signed in September 2023, the IMEEC will connect

western Indian ports to Europe via the Arabian Gulf through a network of rail and ship routes. The IMEEC could potentially increase trade speed by 40% along with reduced costs, thereby driving existing trade and manufacturing and strengthening food security and supply chains. The IMEEC remains a crucial agenda item for participating nations, and it would be important to track how this initiative progresses in the coming months.

#### **FUTURE OUTLOOK**

The FM stated that India is well positioned for unprecedented growth and development over the next 5 years, owing to its strong performance over the past, thereby inspiring confidence in the economy. As per a Global Financial Agency, India is likely to become the third-largest economy in 2027 and it is also estimated that India's contribution to global growth will rise by 200 basis points in 5 years. It is also anticipated that India can become a USD 7 trillion economy by 2030. The resilience demonstrated by the Indian economy, as well as the factors discussed above are expected to contribute towards the goal of a 'Viksit' i.e. developed Bharat by 2047.



ssume you are implementing Code of Conduct, Supply Chain Due Diligence, Questionnaires, Risk Analysis - the full programme, and your business partner feels threatened as you address all these human rights and environmental topics highly relevant to you but not to them. And on top of that, you want to carry out a local audit and maybe implement a whistleblowing tool which the employees or even the suppliers of your supplier can use. First, what tensions could transpire and, second, how can you defuse

There are several tensions that could arise if you address human rights and environmental topics with a supplier, who feels threatened by your approach:

Cultural differences: Your supplier may have a different set of values and a different business culture, and they may not prioritise human rights and environmental issues in the same way that you do. This can lead to misunderstandings and conflicting viewpoints.

Fear of change: Your supplier may feel threatened by the changes you are proposing, such as the implementation of a local audit or a whistleblowing tool. They may be concerned about the cost and effort required to implement these changes, or they may be resistant to outside interference in their operations.

Loss of control: Your supplier may feel that they are losing control over their operations and may be concerned about the potential consequences of the changes you are proposing.



To defuse these tensions, it is important to approach the situation with empathy and understanding.

#### Here are a few steps you can take: Communicate clearly and openly:

Highlight the mutual benefits of addressing these issues and explain how they can help to improve the supplier's operations and financial

#### performance. Offer support and resources:

Offer to provide support and resources to help the supplier implement the changes you are proposing, such as training or access to information and best practices. Seek input and feedback: Engage the supplier in a dialogue and seek their input and feedback. This can help to build trust and ensure that any efforts to address human rights and environmental issues are perceived as collaborative and mutually beneficial.



### **Integrating Grievance Systems** For Risk Prevention and Human Rights Compliance

roduction processes along global supply chains are increasingly being scrutinised in terms of their impact on working and living conditions at production sites. This is particularly true for the supply chains of leather, leather goods and footwear, or garment and textile.

The Act on Corporate Due Diligence Obligations in Supply Chains requires companies to conduct appropriate human rights and certain environmental due diligence in their supply chains. The Act came into its first phase of effect on January 1, 2023, for companies headquartered in Germany. This reflects the increasing trend towards regulatory frameworks that are guiding both corporate and government action.

The intention is to drive a shift towards social and ecological transformation of global supply chains, aiming to prevent negative impacts on the environment, societies, and people.

In addition to such frameworks for preventing human rights violations and ensuring that working and production conditions comply with human rights, access to effective remedies is becoming increasingly important. Grievance mechanisms play a crucial role, providing redress for rights violations, supporting corporate risk analysis through the nature of complaints received, and supporting preventive action by enabling intervention at an early stage.



Beyond regulatory compliance, the procedural implementation of due diligence by brands, business partners and other stakeholders including Civil Society Organisations (CSOs) builds a basis for work and stakeholder engagement. This process becomes a key building block and provides an opportunity to responsibly address the risks of human rights violations in the supply chain and implement effective preventive measures. As a Civil Society organisation, we see the potential for progress in solution-orientated social dialogue and cross-stakeholder engagement. Mastering the challenges INKOTA published the Working Paper: An Effective System for Grievances and Remedy in Transnational Supply Chains in cooperation with Prof. Dr. Ulla Gläßer and Helene Bond from the European University Viadrina in Frankfurt

(Oder). This working paper offers companies and initiatives concrete recommendations for action on institutionalizing, implementing, designing procedures and setting up grievance mechanisms as learning systems specifically in supply chains for leather goods and footwear.

The risks and challenges are known e.g. studies on the leather industry and working conditions in Bangladesh, Pakistan, and India by the Together for Decent Leather consortium, but proactive adoption of good practices in risk analysis, prevention, remedy procedures, and robust, reliable stakeholder engagement is imperative.

The events served as platforms to facilitate discussions and collective efforts towards sustainability for Indo-German businesses.
- The FairVoice roadshow, conducted between July and August 2023, encompassed a series of events in India on the topic of grievance mechanisms. The regional events – conducted in Kolkata, Ahmedabad, Chennai, and Pune – shed valuable insights through expert discussions, company best practices, and interactive sessions.

To further shed light on the topic of grievance mechanisms, we published "Building Bridges to Supply Chain Integrity: A Roadmap for Implementing Inter-**Company Grievance Redressal** 





in India". Developed with the Alliance for Integrity, the technical publication outlines steps for the development and practical implementation of supply chainwide 'inter-company' grievance mechanisms in India.

 We also launched SustainNews – the Indo-German Sustainability Newsletter, a monthly newsletter to keep IGCC members and stakeholders informed about the latest news developments on

sustainable business in India and Germany.

#### **RECOGNISING CHAMPIONS OF RESPONSIBLE BUSINESS:**

 In its 2023 edition, SustainAwards recognised Small and Medium-Sized Enterprises in India making robust efforts in their responsible business practices. Applicants were assessed on their human rights strategy, measures to protect human rights and the

environment, grievance procedure, and responsible finance through a rigorous multi-step process by a multi-stakeholder jury panel and subject matter expert. The award felicitation took place at IGCC's 67th Annual General Meeting (AGM.)

#### **EMPOWERING COMPANIES** THROUGH TRAINING AND **CAPACITY-BUILDING:**

Last year, IGCC SustainMarkets prioritised capacity-building through over 100 hours of training for German and Indian companies, including two batches of the sixweek Supply Chain Due Diligence Manager Certification Course.



### Unlocking European Patents:

New Unitary & Unified Courts

atents protect technical inventions. Similar to other intellectual property rights like trademarks or designs, they thus provide an exception to the principle of freedom of imitation. Legislators around the world have recognized that technical progress is only possible if inventors get a reward for their inventions in the form of exclusivity for a limited period of time.

Generally, patents are granted for inventions that are new and are based on inventive steps. It is very important to note that an invention must not be published prior to filing a patent application. So, it is of utmost importance to file a patent application before any publication. For details, see the author's article in Indo-German Economy of March 2022, pages 53 to 55.

Invented in the 19th century, national patent systems proved insufficient. Inventors needed to file in multiple countries before publication, hindering market analysis. The Paris Convention (1883) offered a one-year grace period to file internationally based on a first application. Recognizing this timeframe's limitations, the Patent Cooperation Treaty (1970) allowed a single application for multiple countries with a 30-month window to choose which countries to pursue patents in.

In Europe, there was an

additional, very important step of harmonization with the signature of the European Patent Convention in 1977, establishing the European Patent Office as an independent organization for granting patents. Today, the European Patent Convention has 38 member countries, including all EU member countries but also non-EU countries like the United Kingdom, Switzerland, Turkey, Norway, and Iceland. Patent protection in countries on the Balkan and even in North Africa and Asia can be obtained through validation and extension agreements.

Until 2023, the European Patent System primarily handled patent granting. After a patent was granted and possibly survived opposition at the European Patent Office, maintenance and enforcement

became the responsibility of individual countries. This required payment of maintenance fees in each desired country, akin to national patents, resulting in significant costs for widespread protection and often leading to patents being maintained in only select countries. Additionally, infringement cases had to be pursued separately in each country, leading to high litigation expenses and potentially conflicting decisions on infringement.

#### **NEW LEGISLATION OF 2023**

Efforts to further harmonize patent law in the EU started decades ago but were always blocked by some countries that were not willing to participate. In 2023, new opportunities to save costs and streamline litigation were finally put into force by using the mechanism of Enhanced Cooperation, offering the possibility to introduce EU legislation for only a subset of EU member countries. The participating countries are Germany, France, the Benelux countries, Austria, Portugal, Denmark, Sweden, Finland, the Baltic countries, Italy, Slovenia, and Bulgaria. For these countries, the possibility to get Unitary Patent Protection and to litigate using the Unified Patent Court, both of which

will be described further below, are now valid. Furthermore, Ireland, the Czech Republic, Slovakia, Hungary, Romania, Greece, and Cyprus have signed the relevant agreement, but have not yet finally performed all necessary ratification steps.

#### **UNITARY PATENT PROTECTION**

One of the two new possibilities introduced in 2023 is the Unitary Patent Protection, being valid in all participating countries. This is possible for almost all newly granted European Patents and means that the patent will be maintained in all these countries similarly as if it would be maintained in just one country. There is only one maintenance fee to be paid on a yearly basis. In general, it can be said that the Unitary Patent Protection is in most cases cheaper if the patent should be maintained in more than four usually selected countries. However, there will be no possibility to let the patent lapse in one of these countries separately. Should there be a challenge to the validity of the patent, the patent will be maintained, restricted, or revoked with identical effects for all participating countries.

It should be consulted individually with a competent patent attorney if Unitary Patent Protection is suitable after grant, or if the patent should be validated and maintained according to the classical scheme on a national basis.

#### **UNIFIED PATENT COURT**

The Unified Patent Court (UPC) is a highly specialized court having jurisdiction over patent matters for all participating countries. The idea is that a patent proprietor can litigate patent infringement using the UPC with only one proceeding and that the decision is valid for all participating countries. Likewise, a nullity proceeding may be initiated against a patent with validity for all participating countries.

The UPC has exclusive jurisdictions for all Unitary Patents (see section 3). This means that if the patent proprietor has decided to use the newly introduced Unitary Patent Protection, usage of the UPC for both litigation of infringement and nullity proceedings is mandatory for the participating countries. For other countries (like Switzerland or the United Kingdom), national courts remain competent.

However, the UPC is also competent for all other granted European Patents, even if they were granted before establishing the UPC, as long as the patent proprietor has not declared an opt-out. In case of a declared opt-out, national courts remain competent even for the participating countries. The Unified Patent Court (UPC)

The Unified Patent Court (UPC) offers distinct benefits over national courts for patent disputes. Court fees are notably lower compared to German national court fees, particularly for high-value disputes. Jurors can include technical experts, enhancing the court's technical proficiency and lessening the need for additional expert opinions. European Patent Attorneys can represent parties independently, eliminating the necessity for two

attorneys per party. The UPC's procedural rules aim to deliver a firstinstance decision within one year, providing swift legal clarity.

Of course, the usage of the UPC requires confidence in the new court system. However, many competent judges with a high level of experience in the national court systems of the participating countries now also work as judges for the UPC, so it is to be expected that the UPC can provide a high quality of work from its beginning. Most large European companies do not opt out of their patents and trust in the new system.

An opt-out may especially be considered for patents with a very high specific value, for example, patents protecting a blockbuster drug in the pharmaceutical industry, because after opt-out of a patent being valid in many countries the burden to successfully attack the patent is significantly increased, as a plurality of national proceedings are necessary. It should be consulted with a competent patent attorney in each case if an opt-out makes sense or not.

#### CONCLUSION

The new European Unified Patent System offers new possibilities to save costs and streamline patent litigation for a significant part of European Union member countries. This especially provides advantages for small and medium-sized companies, who can maintain and enforce their patents with reduced costs and effort.

## **Insights into the Interim Budget 2024**

he 2024 Interim Union Budget prioritizes India's holistic development, aiming for a Developed Nation status by 2047. The upcoming five years will emphasize significant progress, especially in empowering the youth, women, farmers, and the economically disadvantaged.

Further, the 'First Develop India' strategy during the 'Amrit Kaal' (till the year 2047) centers around investments in infrastructure, maintaining growth momentum in Foreign Direct Investment (FDI), fostering sustainable and inclusive development, and promoting the thrust sectors in India.

The Interim Union Budget for 2024 reveals an optimistic outlook, anticipating a reduction in the revised fiscal deficit from 5.8% in the Financial Year (FY) 2023-24 to 5.1% in FY 2024-25. Similarly, inflation is expected to decrease from 6.7% in FY 2023-24 to 5.5% in FY 2024-25. These key economic indicators signal a promising future for the Indian economy, even amidst global economic uncertainties.

The Finance Bill, 2024 presented on 1 February 2024 received Presidential assent on 15 February 2024, and has been enacted.

Given its interim nature, and as was expected the budget did not introduce extensive changes in tax regulations. Some key taxrelated amendments/proposals are outlined in the following paragraphs:

#### **PROPOSALS UNDER DIRECT TAX REGULATIONS**

No major amendments in the Direct Tax are introduced, except rationalization of some due dates. Changes enacted are as follows:

- No changes to the income tax rates and slabs in the Interim Union Budget 2024. Accordingly, the income tax rates and slabs for FY 2023-24 to be continued for FY 2024-25.
- Section 206C(1G) of the Income Tax Act, 1961 ('ITA') has been amended to align the same with the Government's Press Release dated 28 June 2023 on scope and rates of Tax Collection at Source ('TCS') for remittances under the Liberalized Remittance Scheme of Reserve Bank of India and remittance towards overseas tour program package. In a nutshell, no new amendments are made and only earlier announcements made via Press Releases and Circulars have now been incorporated into the Income tax law.
- The sunset clauses for startups' deduction, certain categories of income of International Financial Services Centre ('IFSC') units are extended from 31 March 2024 to 31 March 2025.

- Due Date for Faceless Scheme of Transfer Pricing Officer, Dispute Resolution Panel, Appellate Tribunal has been extended from 31 March 2024 to 31 March 2025.
- ◆ A significant announcement was made by the Hon'ble Finance Minister to clear out existing outstanding income tax demands in the case of taxpayers up to INR 0.025 Million for the FYs up to FY 2009-10, and INR 0.010 Million for FYs 2010-11 to 2014-15. Such demands are proposed to be written off. The Government expects this move to benefit around 10 Million taxpayers.
- The sunset clause for the commencement of manufacturing by domestic companies opting for the 15% corporate tax rate under section 115BAB of the ITA, originally set for March 31, 2024, hasn't been extended. The upcoming full Budget from the new Government may reconsider and extend this deadline. Additionally, there are no announcements on Pillar II developments of Base Erosion Profit measures, which might be addressed in the full Budget.


